



### Understand the taxes and fees on your electric bill

LCEC has not raised electric rates for nearly five years!! This has been accomplished through fiscal responsibility, process improvements and strategic use of technology. However, you may notice there are charges on your bill that aren't related to electricity. Not all customers pay these additional fees/taxes, but they are becoming more and more common as legislators utilize them to generate revenues.

Public Service Tax – Tax on utilities. Utilities are required to collect the tax through utility bills, and funds are delivered to local government. (7% in Cape Coral, 8% in Everglades City)

**Gross Receipts Tax** – A tax on the sale, delivery or transportation of gas or electricity. Collected funds are delivered to State government. (2.5% in Florida)

Franchise Fee – A fee paid through an agreement to allow use of public easements for location of power facilities such as wires crossing the road or poles along roadways. Funds are delivered to local governments. (3% in Cape Coral, 3% on Sanibel, 3% in Everglades City)\*

\*Lee County Commissioners are considering a fee for Lehigh Acres, North Fort Myers, Pine Island and Captiva Island

Any member who is a resident of the district that is up for election can apply to be considered by the Nominating Committee. All applications are considered. Each year there are at least three seats up for election. Terms are staggered to provide continuity on the Board.

## **LCEC Donates Materials to Collier Reef Project**

Last month, LCEC partnered with the Collier County Artificial Reef

organization to deliver scrap materials that will help reduce the cost of the project. The program is in full swing, and this delivery was just the first of many donations to be made by LCEC at the Collier County Landfill.

Collier County received BP Grant funds, and the City of Marco Island and the City of Naples began accepting clean materials for use in the deployment of the 36 artificial reefs. Conservative estimates are that these reefs are expected to boost tourism by nearly \$35 million dollars.

Ways to decorate your home with lighting while paying attention to the energy being used.

- Use solid-state LED holiday lights and strands which use about 99 percent less energy than the larger, traditional incandescent lights.
- LED lights last up to 100,000 hours, so you should pack them away carefully for next year.
- Timers are good on outdoor light displays. Keep them on for a set time period. You can quadruple your energy costs if you leave your holiday lights on all the time instead of just five or six hours.
- If you're lighting a Hanukkah menorah, a dimmer switch will let you enjoy the candles even more. By the eighth night of the holiday, in fact, you might not even need any electric lights.
